

## LONDON STADIUM VENUE REGULATIONS – Major League Baseball London June 2023

**Notice: Entry to the Stadium shall constitute acceptance of the Stadium Regulations.**

"**Stadium**" means the London Stadium and all locations owned, occupied or utilised by London Stadium 185 Ltd.

"**Material**" means any audio, visual or audio-visual material or any information or data.

1 Notwithstanding possession of any ticket London Stadium 185 Ltd, any police officer or authorised steward may **refuse entry to (or eject from)** the Stadium any person:

1.1 that fails (or in London Stadium 185 Ltd.'s reasonable opinion is likely to fail) to comply with these Stadium Regulations or any reasonable instruction issued by a police officer or authorised steward; and/or

1.2 whose presence within the Stadium is or could (in London Stadium 185 Ltd.'s reasonable opinion), constitute a source of danger, nuisance or annoyance to any other person.

2 London Stadium 185 Ltd excludes to the maximum extent permitted by law any liability for loss, injury or damage to persons/property in or around the Stadium.

3 No guarantees can be given by London Stadium 185 Ltd that an event will take place at a particular time or on a particular date and London Stadium 185 Ltd reserves the right to reschedule the event without notice and without any liability whatsoever.

4 PROMOTER'S conditions apply in respect of any refunds

5 All persons seeking entrance to the Stadium acknowledge London Stadium 185 Ltd.'s right to search any person entering the Stadium and to refuse entry to or eject from the Stadium any person refusing to submit to such a search. Searches will be undertaken using Magnetic arches which are certified for use by all major airports. All customers must pass through these arches unless they have a medical reason and they must then pass through the accessible lanes and be subject to either a magnetic wand search or personal 'pat down' search.

All bags will be subject to search including all pockets – open your bag ready for search. No bag larger than 40 cm x 40 cm x 20 cm will be allowed entry (16" x 16" x 8").

6 If any person brings or attempts to bring into the Venue, possesses or uses within the Venue or in the vicinity thereof any Illegal or Prohibited Item including, without limitation: firearms and ammunition (including component parts) or replica, pellet or imitation firearms or ammunition; all types of knives and bladed items (including pocket knives and box cutters); offensive weapons or implements, such as extendable batons, machetes, chains and knuckledusters, or any items modified into weapons or replica or imitation weapons; baseball bats; inflatable balls or beach balls; controlled drugs or new psychoactive substances; explosives, fireworks, flares, pepper spray or mace, smoke canisters or replica explosive devices, personal protection sprays, laser pointers & strobe lights; hard sided coolers; glass bottles and glass receptacles (medication bottles for personal use excluded); hazardous and/or toxic materials (including chemical or incendiary devices); any instrument defined as a weapon by English law; cans or any other item that an Authorised Person considers dangerous, hazardous and/or illegal or that may be used as a weapon or a missile or that may compromise or otherwise interfere with the safety of (or pose a hazard to) any person or security at the Venue including:

- 6.1. phone jammers, radio scanners and walkie-talkies; personal/private wireless and 3G or 4G or 5G access points/hubs (smart devices are permitted but must not be used as wireless access points to connect multiple devices);
- 6.2 any bag that is bigger than a piece of A4 paper in length, width and depth;
- 6.3 compressed gas containers including aerosols (other than as required for personal medical purposes);
- 6.4 protest material of any kind, including banners, clothing, signs or materials displaying political, religious, offensive or race-related messages, slogans or images;
- 6.5 tents, spray paint or any other item which could be used to demonstrate within a Venue, sabotage or damage property;
- 6.6 any objects bearing trademarks or other kinds of promotional signs and messages (of whatever nature) which MLB believe may be used for promotional or ambush marketing purposes;
- 6.7 any tripods or video camera equipment whatsoever (whether or not for personal use); and any camera or other type of photographic or recording device (of any nature whatsoever and whether capturing still or moving pictures) other than for personal use;
- 6.8 bicycles, roller-skates, skateboards, scooters, wheeled footwear and similar items;
- 6.9 any items of high-visibility clothing;
- 6.10 pets or animals (other than guide/service dogs); and
- 6.11 any item(s) expressly prohibited pursuant to the Venue Regulations they will be refused entry or items confiscated / police assistance secured.

7. Further, you may not bring into the Stadium any sponsorship, promotional or marketing materials save in respect of official MLB / Stadium merchandise and/or other clothing worn in good faith nor may you offer (either free or for sale by any person) any goods (including literature) of any nature without the express written approval of London Stadium 185 Ltd.'s management.

8. The use of threatening behaviour, foul or abusive language is strictly forbidden and will result in arrest and/or ejection from the Stadium. London Stadium 185 Ltd may impose a ban on entering the in the future.

9. Racist, homophobic or any form of discriminatory abuse, chanting or harassment is strictly forbidden and will result in arrest and/or ejection from the Stadium. London Stadium 185 Ltd may impose a defined period or lifetime ban.

10. The following acts may result in bans, civil prosecution and criminal charges:

- 10.1 The throwing of any object within the Stadium without lawful authority or excuse.
- 10.2 The chanting of anything of an offensive, discriminatory, indecent or racist nature.
- 10.3 Going onto the field of play or surrounding area without authorisation.

11 All persons entering the Stadium may only occupy the seat allocated to them by their ticket and must not move from any one part of the Stadium to another without the express permission or instruction of any steward, officer of London Stadium 185 Ltd and/or any police officer.

- 11.1 Anyone who attempts to forge any form of accreditation (including but not limited to credentials, stickers, passes, and wristbands) will be removed from stadium
- 11.2 Any person on the London Stadium Island without any legitimate means of accreditation or reason will be removed from the Stadium Island and will be passed to the police.

13 The obstruction of gangways, access ways, exits and entrances, stairways and like places is strictly forbidden. Nobody entering the Stadium shall be permitted to climb any structures within the Stadium.

14. This Stadium is smoke-free and smoking (**INCLUDING E CIGARETTES**) is not permitted inside the Stadium. If designated external open areas are dedicated to smoking only these must be used at times permitted and indicated.

15. Mobile telephones and other mobile devices are permitted within the Stadium PROVIDED THAT:

15.1 they are used for personal and private use only (which, for the avoidance of doubt and by way of example only, shall not include the capturing, logging, recording, transmitting, playing, issuing, showing, or any other communication of any Material for any commercial purposes);

15.2 No Material that is captured by a mobile telephone or other mobile device may be published or otherwise made available to any third parties including, without limitation, via social networking sites.

16 Under the Stadium Premises Licence the following are offences for which a person can be arrested by a police officer and conviction could result in a Banning Order being made:

16.1 Attempting to enter the Stadium or being inside the Stadium whilst drunk;

16.2 Being in possession of any intoxicating liquor, or bottle, can or other portable container (unless MLB merchandise) and which could cause damage or personal injury, when entering the Stadium

17 Any individual who has entered any part of the Stadium designated for the use of any group of supporters to which he/she does not belong may be ejected from the Stadium either for the purposes of his/her own safety or for any other reason.

19 Save as set out in paragraph 15 above, no person (other than a person who holds an appropriate licence) may capture, log, record, transmit, play, issue, show or otherwise communicate (by digital or other means) any Material in relation to the Game, any players or other persons present in the Stadium and/or the Stadium, nor may they bring into the Stadium or use within the Stadium (or provide to, facilitate or otherwise assist another person to use within the Stadium) any equipment or technology which is capable of capturing, logging, recording, transmitting, playing, issuing, showing or otherwise communicating (by digital or other means) any such Material. Copyright, database rights and any other intellectual property rights in any unauthorised recording or transmission is assigned (by way of present assignment of future rights) to **MLB and its Agents** .

20 No goods (including literature) of any nature may be offered either free or for sale by any person within the Stadium without the express written permission of London Stadium 185 Ltd.

21 Tickets are not transferable and may not be offered for sale without the prior written permission of London Stadium 185 Ltd- or otherwise in accordance with the relevant ticket terms and conditions. Any tickets that are transferred are transferred subject to these Stadium Regulations. Any tickets offered for sale may be confiscated by any steward, officer of London Stadium 185 Ltd or any police officer. London Stadium 185 Ltd reserves the right to refuse admission to or eject from the Stadium and/or

"blacklist", any person who has offered for sale or transferred his/her ticket in contravention of the relevant ticket terms and conditions (and/or the holder of any ticket that has been transferred in contravention of the relevant ticket terms and conditions). Tickets remain the property of the Promoter / London Stadium 185 Ltd at all times.

22 CCTV cameras are in use around and in the Stadium. Body worn video cameras recording video and/or audio may also be used as appropriate, for example to record prohibited behaviours as referenced in paragraphs 9 and 10. London Stadium 185 Ltd may itself use or pass to the police or any Authority or other Stadiums, any recordings for use in any proceedings.

23 At all times whilst present in the Stadium, persons must comply with any and all instructions of any steward or officer of London Stadium 185 Ltd and/or any police officer. Failure to comply with any instruction may lead to immediate ejection from the Stadium.

24 By entering the Stadium, all persons are acknowledging that photographic images and/or video recordings (and/or stills taken from video recordings) may be taken of them and may also be used, by way of example and without limitation, in televised coverage of the game or by or on behalf of London Stadium 185 Ltd (or their commercial partners) for marketing, training or promotional purposes. Entry into the Stadium is confirmation that all persons have consented to such use of their image. If these images should feature an individual prominently London Stadium 185 Ltd will make reasonable efforts to gain the consent of that person before publishing such images, however, if this is not possible, then entry into the Stadium shall be deemed consent unless London Stadium 185 Ltd is notified in writing to the contrary.

25 Further to paragraph 24, if such person is under 18 years of age, the parent, guardian, or responsible adult who is accompanying them into the Stadium shall be deemed to have provided consent on their behalf.

26. The nature of a baseball game is such that it may run for an extended period of time past the last public transport times for some lines. Should the game still be in progress after 5 hours with a start at 18:10 MLB and London Stadium will make announcements advising patrons to make their way to transport hubs. This is public service assistance for the safety and comfort of customers - there will be no refund if the game is still in progress.

**26 Refused entry to (or ejection from) the Stadium may lead to further action by London Stadium 185 Ltd including, but not limited to, the withdrawal of any season ticket (without reimbursement), Stadium Membership and other benefits.**
